Paying the Registration Fee the Team has the right to race in all the ITKC 2016 events, as listed in the Rules and Regulations file, available at www.kattrace.it or www.itkc.it

After having sent the present form, the Team MUST make the payment of the Team Fee. In case of recess before or after the payment, the Team Registration will remain acquired in any case by the Organizer., but faculty will be given to let another Team to take part to the ITKC 2016, with the relative race number.

The Team can consider himself registered only after having paid the registration fee in full. Payment conditions must be considered as they are written in this form. Any variation must be accepted by the Organizer. and /or its Promoters, in writing. A deposit of 50% must be made until April 18, 2016 and paid in full until May, 2. 3. GENERAL CONDITIONS The Teams must respect the Rules and Regulations (R.d.C.) and the dispositions of the A.C.S.I.

The Teams must respect the Rules and Regulations (R.d.C.) and the dispositions of the A.C.S.I. The Organizer and its Promoters cannot be in any way held responsible of disciplinary decisions taken by the Race Director and/or the Race Committee. Possible disqualifications and/or decision of different nature, won't block any right of the Organizer and its Promoters. regarding this registration form. In the case of an unexpected greater strength situation will prevent a competition to take place, independent from the wish of the Organizer, the competition will be postponed and recovered in a new date decided by the Organizer himself. In this case reimbursements of any nature won't be recognized to the Teams and the quota to participate in the new competition will have to be paid from the Teams. If a racetrack becomes unavailable for causes of greater strength, the Organizer will communicate a new racetrack and/or a new date for the Event, without any further consequence. In the case in which the "ITKC 2016" could not take place for cause of greater strength or the lack of the minimum number of registrations, the Organizer and/or its Promoters will owe the sole reimbursement and exclusively the quota paid by the Teams, without penalties of any sort. All the Drivers must have a valid Medical Certificate proving their Good Health Status. The Organizer and its Promoters have the right to cancel the TIKC 2016 ir an euogh number of registrations is not reached. In this case the fees will integrally refunded and the Teams unconditionally accept they won't have any right to ask the Organizer and /or its Promoters for any form of penalty.

The official referral of the team with the Organization and the Sport Authority will be the Team Manager that must inform the members of his/her own Team about the Rules and Regulations (R.d.C.) 4. EXTRA SERVICES

The Drivers must have a valid Medical Certificate proving their Good Health Status that is compulsory to obtain the A.C.S.I. Membership, valid one year, for all the races of the ITKC 2016. The racing equipment is compulsory. Drivers who do not own it can buy the equipment from the Organizer or in a specialized shop. For all the Teams will be possible to directly purchase from the Organizer personalized advertising material like banners, and Teamwear Also stickers set for the kart are available, digitally printed with the Team's logos and colors, to a special price of €90.00+V.A.T. (if applicable),with vector files given by the Team ready for printing. The services above listed (and relative quotations) will have to be demanded to The Organizer or its Promoters, within a term of 30 days from the beginning of the competition.
