In consideration of renting and operating a go-kart (KF chassis with Briggs & Stratton Series 2100 4 stroke engine) at the above specified Racetrack, during the "ITKC 2017 – 24hr Racing Event", I hereby release CAP asd, its members, agents, employees, partners landlord, successors or assigns, from any and all liability, claims demands, actions, and causes of action whatsoever, whether foreseen or unforeseen, arising out of or related in any way to my renting and operating a go-kart that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs, or assigns, and further to save and hold harmless CAP asd, its members, agents, employees, partners, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by its negligence.

I understand that this activity is dangerous and may become more hazardous or dangerous during the time I am on the premises of the Racetrack, that the risk of injury from the operation of a go-kart is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with my operating a go-kart at the Racetrack and hereby voluntarily assume all risk of loss, damage and injury, including death, that may be sustained by me or any property of mine while at the Racetrack. This release shall be binding upon my family, estate, heirs, or assigns. CAP asd and/or its Partners, may utilize photographic, video or other images of myself for subsequent advertising and promotion purposes without any fee or consideration to myself.

In signing the foregoing Waiver Form, I acknowledge and represent:

- (a) That I have read the foregoing Liability Release, understand it, and sign it voluntarily;
- (b) That I am at least 14 years, that I own a A.C.S.I. Membership Registration and I gave a Valid Medical certificate to the Organizer's Sport Office proving my good health status;
- (c) That I am not pregnant;
- (d) That I have not consumed alcohol or drugs, which may affect my ability to drive a go-kart in a safe manner;
- (e) That I do not suffer from a heart condition, high blood pressure or other medical condition which may be aggravated by my operating a go-kart;
- (f) That I will wear a helmet and homologated technical equipment while operating a go-kart or otherwise while in or around the racetrack;
- (g) That I know and I will obey all Rules and Regulations of the "ITKC 2016" (they can be found on the site www.itkc.it), and all the regulation of the A.C.S.I.insurance policy
- (h) That I will closely observe and follow the instructions of all facility personnel;
- (i) That this agreement is continuing and shall remain in effect until the end of the "ITKC 2016" racing Events
- (l) That I will not permit to drive the go-kart assigned to my Team to other people except the drivers of my Team, officially registered at the "ITKC 2016" racing events. If not I hold harmless CAP asd, its members, agents, employees, partners, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by my negligence.
- (m) That I have accepted the A.C.S.I. Insurance Rules and Regulations, and I accept the insurance coverage provided.
- (n) That I will use valid Racing wear only.

The Team Manager and all the Drivers declares that their personal data on this "Waiver Form and Drivers List" are true. They declare also to know the Italian Privacy Protection Law (Art. 10 comma 1 and 13, of the Law nr 675 , 31/12/1996) and permit that all the personal data will be stored and used by CAP asd and/or its Promoters., . They grant also to CAP asd, its representatives and employees the right to take photographs of them and their property in connection with the above-identified subject. They authorize CAP asd, its assigns and transferees to copyright, use and publish the same in print and/or electronically.
