In consideration of renting and operating a go-kart (Birel n035-x with 4strokes Engine) at the above specified Racetrack, during the "Kart Endurance Trophy 2010", I hereby release Kart4Fun S.r.l. and Sogekart S.r.l., its members, agents, employees, partners landlord, successors or assigns, from any and all liability, claims demands, actions, and causes of action whatsoever, whether foreseen or unforeseen, arising out of or related in any way to my renting and operating a go-kart that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs, or assigns, and further to save and hold harmless Kart4Fun S.r.l. and Sogekart S.r.l., their members, agents, employees, partners, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by its negligence.

I understand that this activity is dangerous and may become more hazardous or dangerous during the time I am on the premises of the Racetrack, that the risk of injury from the operation of a go-kart is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with my operating a go-kart at the Racetrack and hereby voluntarily assume all risk of loss, damage and injury, including death, that may be sustained by me or any property of mine while at the Racetrack. This release shall be binding upon my family, estate, heirs, or assigns. Kart4Fun S.r.l. and Sogekart S.r.l., may utilize photographic, video or other images of myself for subsequent advertising and promotion purposes without any fee or consideration to myself.

**In signing the foregoing Waiver Form, I acknowledge and represent:**

- (a) That I have read the foregoing Liability Release, understand it, and sign it voluntarily;
- (b) That I am at least 18 years old;
- (c) That I am not pregnant;
- (d) That I have not consumed alcohol or drugs, which may affect my ability to drive a go-kart in a safe manner;
- (e) That I do not suffer from a heart condition, high blood pressure or other medical condition which may be aggravated by my operating a go-kart;
- (f) That I will wear a helmet and homologated technical equipment while operating a go-kart or otherwise while in or around the racetrack;
- (g) That I know and I will obey all rules and regulations of the "Endurance Trophy 2010"(they can be found on the sites [www.endurancetrophy.com](http://www.endurancetrophy.com)), and all the regulation of the C.S.A.I. (Commissione Sportiva Automobilistica Italiana [www.csai.aci.it](http://www.csai.aci.it));
- (i) That I will closely observe and follow the instructions of all facility personnel;
- (j) That this agreement is continuing and shall remain in effect until the end of the "Endurance Trophy 200910"
- (k) That I will not permit to drive the go-kart assigned to my Team to other people except the drivers of my Team, officially registered at the "Endurance Trophy 2010". If not I hold harmless Kart4Fun S.r.l. and Sogekart S.r.l., their members, agents, employees, partners, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by my negligence.
- (l) That I have accepted the C.S.A.I. Driver's Insurance Rules and Regulations, and I accept the following maximal sum insurable: € 52.000 in case of death, € 52.000 in case of permanent disablement ( with 5% fee), €2.600 for medical expenses refund, in case of hospitalization only.
- (m) That I will use valid homologated Racing wear only, as required by the C.S.A.I./ C.I.K. and that I have a valid Racing Card (C.I.K./F.I.A. compliant) or I have asked for a C.S.A.I. Corporate License, annual duration or valid for this event only.
