In consideration of renting and operating a go-kart (Birel n035-x with Honda 4strokes Engine) at Milan City Fair, during the Kart Endurance Race, 27/28/29 of June, 2008, I hereby release T-WE S.r.l., their members, agents, employees, partners landlord, successors or assigns, from any and all liability, claims demands, actions, and causes of action whatsoever, whether foreseen or unforeseen, arising out of or related in any way to my renting and operating a go-kart at Milan City Fair that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs, or assigns, and further to save and hold harmless T-WE S.r.l., their members, agents, employees, partners, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by its negligence.

I understand that this activity is dangerous and may become more hazardous or dangerous during the time I am on the premises of Milan City Fair, that the risk of injury from the operation of a go-kart is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with my operating a go-kart at Autodromo Nazionale di Monza and hereby voluntarily assume all risk of loss, damage and injury, including death, that may be sustained by me or any property of mine while at Milan City Fair.

This release shall be binding upon my family, estate, heirs, or assigns. T-WE S.r.l., may utilize photographic, video or other images of myself for subsequent advertising and promotion purposes without any fee or consideration to myself.

### In signing the foregoing Liability Release, I acknowledge and represent:

- (a) That I have read the foregoing Liability Release, understand it, and sign it voluntarily;
- (b) That I am at least 18 years old; (16 years old if I have a valid racing card, F.I.A. compliant and I have the permission of my Parents).
- (c) That I am not pregnant;
- (d) That I have not consumed alcohol or drugs, which may affect my ability to drive a go-kart in a safe manner;
- (e) That I do not suffer from a heart condition, high blood pressure or other medical condition which may be aggravated by my operating a go-kart;
- (f) That I will wear a helmet while operating a go-kart or otherwise while in or around the racetrack;
- (g) That I will obey all rules and regulations of the “Coppa della Campionaria”, and all the regulation of the F.I.K. (Italian Karting Federation);
- (i) That I will closely observe and follow the instructions of all facility personnel;
- (j) That this agreement is continuing and shall remain in effect until the end of the “Coppa della Campionaria”
- (k) That I will not permit to drive the go-kart assigned to my Team to other people except the drivers of my Team, officially registered at the “Coppa della Campionaria”. If not I hold harmless T-WE S.r.l., their members, agents, employees, partners, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by my negligence.
- (l) That I have accepted the F.I.K. (Italian Karting Federation) Driver's Insurance Rules and Regulations, and I accept the following maximal sum insurable: € 52.000 in case of death, € 52.000 in case of permanent disablement (with 5% fee), €2.600 for medical expenses refund, in case of hospitalization only.
- (m) That I will use valid homologated Racing wear only, as required by the F.I.K. (Italian Karting Federation and that I have a valid Racing Card (F.I.A. compliant) or I have asked for a F.I.K. Corporate Licence, valid for this event only.
